You are hereby notified that the Pennsylvania Judicial Conduct Board has determined that there is probable cause to file formal charges against you for conduct proscribed by Article V, § 17(b) and § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania, and the Rules Governing Standards of Conduct of Magisterial District Judges. The Board's counsel will present the case in support of the charges before the Pennsylvania Court of Judicial Discipline.

You have an absolute right to be represented by a lawyer in all proceedings before the Court of Judicial Discipline. Your attorney should file an entry of appearance with the Court of Judicial Discipline within fifteen (15) days of service of this Board Complaint in accordance with C.J.D.R.P. No. 110.

You are hereby notified, pursuant to C.J.D.R.P. No. 302(B), that should you elect to file an omnibus motion, that motion should be filed no later than thirty (30) days after the service of this Complaint in accordance with C.J.D.R.P. No. 411.

You are further hereby notified that within thirty (30) days after the service of this Complaint, if no omnibus motion is filed, or within twenty (20) days after the dismissal of all or part of the omnibus motion, you may file an Answer admitting or denying the allegations contained in this Complaint in accordance with C.J.D.R.P. No. 413. Failure to file an Answer shall be deemed a denial of all factual allegations in the Complaint.

COMPLAINT

AND NOW, this 10th day of October, 2025, comes the Judicial Conduct Board of the Commonwealth of Pennsylvania (Board) and files this Board Complaint against the Honorable Judge Jonathan M. Wilcox, Magisterial District Judge for Magisterial District 42-3-01, Bradford County, Pennsylvania, alleging that Judge Wilcox has violated the Rules Governing Standards of Conduct of Magisterial District Judges and the Constitution of the Commonwealth of Pennsylvania, as more specifically delineated herein.

FACTUAL ALLEGATIONS

1. Article V, § 18 of the Constitution of the Commonwealth of Pennsylvania grants to the Board the authority to determine whether there is probable cause to file formal charges against a judicial officer in this Court, and thereafter, to prosecute the case in support of such charges in this Court.
2. From March 28, 2000, to the present, Judge Wilcox has served as Magisterial District Judge for Magisterial District 42-3-01, Bradford County Pennsylvania.

Commonwealth v. DMN & Commonwealth v. CKR:

3. On December 1, 2024, Trooper Jeremy Seabridge filed a citation for summary harassment in the matter of *Commonwealth v. DMN*,¹ MJ-42301-NT-306-2024.
4. On December 1, 2024, Trooper Jeremy Seabridge filed a citation for summary harassment in the matter of *Commonwealth v. CKR*, MJ-42301-NT-307-2024.
5. DMN was the alleged victim in the matter of *Commonwealth v. CKR*, MJ-42301-NT-307-2024.
6. CKR was the alleged victim in the matter of *Commonwealth v. DMN*, MJ-42301-NT-306-2024.
7. On January 23, 2025, DMN met with Judge Wilcox regarding the pending cases.
8. DMN provided Judge Wilcox with the unopened envelope that contained CKR's citation and her citation.
9. During the January 23, 2025 discussion, Judge Wilcox scheduled to meet with DMN again on January 24, 2025, at 11:00 AM to address the two (2) pending matters.
10. During Judge Wilcox's January 23, 2025 meeting with DMN, he provided DMN with his personal cell phone number.
11. After the January 23, 2025, meeting, Judge Wilcox texted DMN details about his personal life.
12. The morning of January 24, 2025, DMN texted Judge Wilcox asking whether they should meet at a coffee shop or at his judicial office.

13. Judge Wilcox responded with the following text "Meet me at the office as I want to go over the citations with you. I need to make things legitimate if you know what I mean. See you soon...."
14. On January 24, 2025, Judge Wilcox met with DMN in his office.
15. On January 24, 2025, Judge Wilcox dismissed the matter of *Commonwealth v. CKR*, MJ-42301-NT-307-2024.
16. On January 24, 2025, Judge Wilcox typed the following in the case notes for *Commonwealth v. CKR*, MJ-42301-NT-307-2024. "I spoke the victim of the crime. She stated that she did not want to pursue any charges against the defendant and vis versa. As neither party will testify the events of that day case dismissed. There is no need for the Trp to travel from his new station in Laporte to here for a case that will be dismissed. **jmw.**" (grammatical and spelling errors in original) A copy of this MDJS case entry is attached hereto as Exhibit A, made a part hereof, and incorporated herein as though set forth in full.
17. On January 24, 2025, Judge Wilcox entered the following case notes for *Commonwealth v. DMN*, MJ-42301-NT-306-2024. "The Defendant spoke to me and state that she went to the police and never thought that they would file charges against her and the other party, her boyfriend. Defendant just wanted to report the situation but wanted nothing done by law enforcement. As neither one of them wants to testify against each other on these events. Therefore, this case along with the other case are being dismissed. There is no reason for the Trp to come from Laporte to have the charges dismissed at the hearing as parties are not going to testify against each other. **jmw.**"

(Grammatical errors in original). A copy of this MDJS case entry is attached hereto as Exhibit B, made a part hereof, and incorporated herein as though set forth in full.

18. Judge Wilcox never discussed the above matters with Trooper Seabridge.
19. CKR was unaware he had been charged with a summary offense.
20. CKR was unaware he was the alleged victim of DMN's summary offense.
21. Judge Wilcox instructed his staff to get rid of DMN and CKR's files.
22. Judge Wilcox advised his staff not to discuss his actions in the DMN matter with anyone and if they did, he would know they had leaked the information.
23. Between January 23, 2025, and January 29, 2025, Judge Wilcox texted DMN numerous times. A copy of the text exchange is attached hereto as Exhibit C, made a part hereof, and incorporated herein as though set forth in full.
24. In Judge Wilcox's last text message sent at 10:23 PM on January 29, 2025, he acknowledged he would be required to recuse from any further matters involving DMN and CKR.
25. Judge Wilcox dismissed DMN's case on May 19, 2025.

Commonwealth v. Hope Michelle Short:

26. On November 4, 2022, at *Commonwealth v. Hope Michelle Short*, Judge Wilcox issued a Commitment for the following traffic offenses wherein he sentenced Ms. Short to serve a term of imprisonment of one-hundred-fifty-one (151) days from November 4, 2022, until April 4, 2023:

27. Judge Wilcox did not hold a payment determination hearing prior to issuing the November 4, 2022, Commitment.
28. On March 6, 2025, Judge Wilcox issued a second Commitment wherein he sentenced Ms. Short on the above dockets to a sentence of sixteen (16) days on March 22, 2025.
29. Judge Wilcox did not hold a payment determination hearing before issuing the March 6, 2025 Commitment.
30. Ms. Short was released on March 10, 2025, after she paid the remaining fines and costs.

CHARGES

Counts 1 – 2– Violation of Canon 1, Rule 1.1

31. By virtue of some or all of the conduct alleged in paragraphs 21, and 27 through 32, Judge Wilcox violated Canon 1, Rule 1.1 of the Rules Governing Standards of Conduct of Magisterial District Judges (RGSCMDJ).
32. Canon 1, Rule 1.1 states the following:

Canon 1, Rule 1.1 Compliance with the Law.

A magisterial district judge shall comply with the law, including the Rules Governing Standards of Conduct of Magisterial District Judges.

33. Judge Wilcox committed the crime of obstructing the administration of law when he instructed his staff to get rid of CKR and DMN's files.
34. Judge Wilcox failed to comply with the law when he failed to hold a payment determination hearing for Ms. Short prior to sentencing her to jail time.

Counts 3 - 6– Violation of Canon 1, Rule 1.2

35. By virtue of some or all of the conduct alleged in paragraphs 7 through 17, 21 through 25, and 29 through 32, Judge Wilcox violated Canon 1, Rule 1.2 of the RGSCMDJ.
36. Canon 1, Rule 1.2 states the following:

Canon 1, Rule 1.2 Promoting Confidence in the Judiciary.

A magisterial district judge shall act at all times in a manner that promotes public confidence in the independence, integrity, and impartiality of the judiciary, and shall avoid impropriety and the appearance of impropriety.

37. By meeting with DMN regarding her case prior to the hearing Judge Wilcox failed to promote confidence in the judiciary and avoid impropriety and the

appearance of impropriety within the meaning of Canon 1, Rule 1.2 of the RGSCMDJ.

38. By directing his staff to get rid of DMN and CKR's files, Judge Wilcox failed to promote confidence in the judiciary and avoid impropriety and the appearance of impropriety in violation of Canon 1, Rule 1.2 of the RGSCMDJ.
39. When Judge Wilcox dismissed CKR's citation after meeting with DMN, he failed to promote confidence in the judiciary and avoid impropriety and the appearance of impropriety in violation of Canon 1, Rule 1.2 of the RGSCMDJ.
40. By sentencing Ms. Short to incarceration without a payment determination hearing, Judge Wilcox failed to promote confidence in the judiciary and avoid impropriety and the appearance of impropriety in violation of Canon 1, Rule 1.2 of the RGSCMDJ.

Count 7– Violation of Canon 1, Rule 1.3

41. By virtue of some or all of the conduct alleged in paragraph 23, Judge Wilcox violated Canon 1, Rule 1.3 of the RGSCMDJ.
42. Canon 1, Rule 1.3 states the following:

Canon 1, Rule 1.3 Avoiding Abuse of the Prestige of Judicial Office.

A magisterial district judge shall not abuse the prestige of judicial office to advance the personal or economic interests of the magisterial district judge or others, or allow others to do so.

43. Judge Wilcox abused the prestige of his judicial office when he pursued a relationship with DMN.

Counts 8 -9 – Violation of Canon 2, Rule 2.2

44. By virtue of some or all of the conduct alleged in paragraphs 14 through 25 and 28 through 32, Judge Wilcox violated Canon 2, Rule 2.2 of the RGSCMDJ.

45. Canon 2, Rule 2.2 states the following:

Canon 2, Rule 2.2 Impartiality and Fairness

A magisterial district judge shall uphold and apply the law, and shall perform all duties of judicial office fairly and impartially.

46. Judge Wilcox failed to act with impartiality when he met with DMN and dismissed her and CKR's cases.

47. Judge Wilcox failed to uphold and apply the law when he sentenced Ms. Short to incarceration without a hearing as required under Rule 456 of the Pennsylvania Rules of Criminal Procedure.

Count 10 - Violation of Canon 2, Rule 2.5

48. By virtue of some or all of the conduct alleged in paragraphs 28 through 32, Judge Wilcox violated Canon 2, Rule 2.5 of the RGSCMDJ.

49. Canon 2, Rule 2.5 states the following:

Canon 2, Rule 2.5 Competence, Diligence and Cooperation

(A) A magisterial district judge shall perform judicial and administrative duties competently and diligently.

50. Judge Wilcox violated this rule when he sentenced Ms. Short to incarceration for failing to pay assessed fines without first conducting a hearing regarding her ability to pay as required under Rule 456 of the Pennsylvania Rules of Criminal Procedure.

Counts 11-13 – Violation of Canon 2, Rule 2.6

51. By virtue of some or all of the conduct alleged in paragraphs 15 through 21, and paragraphs 28 through 32, Judge Wilcox violated Canon 2, Rule 2.6 of the RGSCMDJ.

52. Canon 2, Rule 2.6 states the following:

Canon 2, Rule 2.6 Ensuring the Right to be Heard

(A) A magisterial district judge shall accord to every person or entity who has a legal interest in a proceeding, or that person or entity's lawyer or authorized representative, the right to be heard according to law.

53. Judge Wilcox violated this rule when he failed to allow Trooper Seabridge a right to be heard prior to dismissing DMN and CKR's cases.

54. Judge Wilcox violated this rule when he failed to allow CKR his right to be heard regarding his case and DMN's case where he was the alleged victim.

55. Judge Wilcox violated this rule when he failed to allow Ms. Short her right to be heard when he sentenced her to a period of incarceration without a hearing.

Count 14-15 – Violation of Canon 2, Rule 2.9

56. By virtue of some or all of the conduct alleged in paragraphs 7 through 24, Judge Wilcox violated Canon 2, Rule 2.9 of the RGSCMDJ.

57. Canon 2, Rule 2.9 states the following:

Canon 2, Rule 2.9 *Ex parte* Communications

(A) A magisterial district judge shall not initiate, permit or consider *ex parte* communications, or consider other communications made to the magisterial district judge outside the presence of the parties or their lawyers or authorized representatives, concerning a pending or impending matter...

58. Judge Wilcox violated this rule when he met with DMN on January 23, 2025, and January 24, 2025, regarding her pending case.
59. Judge Wilcox violated this rule when he met with DMN on January 23, 2025, and January 24, 2025, regarding CKR's pending case.

Count 16 – Violation of Canon 2, Rule 2.16

60. By virtue of some or all of the conducted alleged in paragraph 22, Judge Wilcox violated Canon 2, Rule 2.16 of the RGSCMDJ.
61. Canon 2, Rule 2.16 states the following:
- (B) A magisterial district judge shall not retaliate, directly or indirectly, against a person known or suspected to have assisted or cooperated with an investigation of a magisterial district judge or a lawyer.
62. Judge Wilcox violated this rule when he advised his staff not to discuss his actions in the DMN matter with anyone and if they did, he would know they had leaked the information.

Counts 17 - 24 – Violation of Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania

63. By virtue of some or all of the conduct set forth above, Judge Wilcox violated Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.
64. Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania states the following:
- Justices and judges shall not engage in any activity prohibited by law and shall not violate any canon of legal or judicial ethics prescribed by the Supreme Court. Justices of the peace shall be governed by rules or canons which shall be prescribed by the Supreme Court.
65. A violation of the RGSCMDJ constitutes an automatic derivative violation of

Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.

66. Judge Wilcox violated Canon 1, Rule 1.1.
67. Judge Wilcox violated Canon 1, Rule 1.2.
68. Judge Wilcox violated Canon 1, Rule 1.3.
69. Judge Wilcox violated Canon 2, Rule 2.2.
70. Judge Wilcox violated Canon 2, Rule 2.5.
71. Judge Wilcox violated Canon 2, Rule 2.6.
72. Judge Wilcox violated Canon 2, Rule 2.9.
73. Judge Wilcox violated Canon 2, Rule 2.16.
74. By violation of all, or some, of the Rules set forth above, Judge Wilcox violated Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.

Count 25– Violation of Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania

75. By virtue of some or all of the conduct set forth above, Judge Wilcox violated Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania.
76. Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania states the following:

A justice, judge or justice of the peace may be suspended, removed from office or otherwise disciplined for . . .conduct which brings the judicial office into disrepute, whether or not the conduct occurred while acting in a judicial capacity [.]
77. By engaging in the conduct set forth above, Judge Wilcox engaged in conduct that was so extreme that it brought the judicial office itself into disrepute and

thereby constitutes a violation of the Disrepute Clause of Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania.

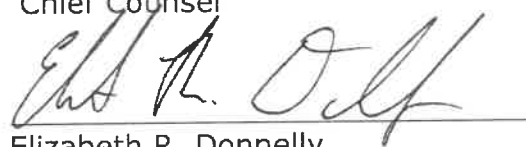

AND NOW, this 10th day of October, 2025, comes the Judicial Conduct Board of the Commonwealth of Pennsylvania (Board), by and through undersigned counsel, and files this Petition For Special Relief For Interim Suspension Without Pay pursuant to Article V, §18(d)(2) of the Pennsylvania Constitution, Rule 701 of the Court of Judicial Discipline Rules of Procedure, and Rule 13(A) of the Judicial Conduct Board Rules of Procedure and in support thereof avers the following:

1. The Pennsylvania Constitution at Article V, §18(d)(2) provides this Court with the authority to impose interim suspension as follows:

Prior to a hearing, the Court may issue an interim order directing suspension, with or without pay, of any justice, judge or justice of the peace against whom formal charges have been filed with the court by the board or against whom has been filed an indictment or information charging a felony. An interim order under this paragraph shall not be considered a final order from which an appeal can be taken.

Pa. Const. art. V, §18(d)(2)

2. From March 28, 2000, to the present, Judge Wilcox has served as Magisterial District Judge for Magisterial District 42-3-01, Bradford County Pennsylvania.
3. Contemporaneously with the filing of this Petition, Board Counsel is filing a Board Complaint against Judge Wilcox, alleging twenty-five counts of

judicial misconduct. A copy of the Board Complaint is attached hereto, made a part hereof and incorporated herein by reference as though set forth in full. **See Attachment "A" (Board Complaint).**

4. The allegations contained in the Board Complaint against Judge Wilcox undermine both confidence in the judiciary and the reputation of the judiciary. If Judge Wilcox is permitted to perform any judicial duties during the pendency of the Board Complaint, the public's confidence in the judiciary will continue to erode.

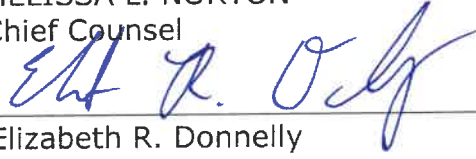

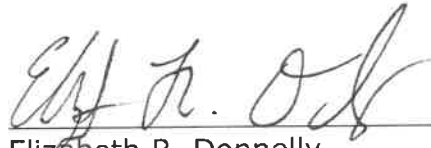

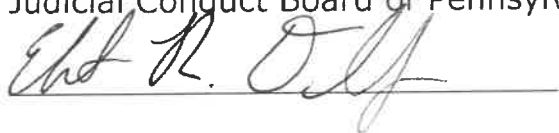

COMPLAINT

AND NOW, this 10th day of October, 2025, comes the Judicial Conduct Board of the Commonwealth of Pennsylvania (Board) and files this Board Complaint against the Honorable Judge Jonathan M. Wilcox, Magisterial District Judge for Magisterial District 42-3-01, Bradford County, Pennsylvania, alleging that Judge Wilcox has violated the Rules Governing Standards of Conduct of Magisterial District Judges and the Constitution of the Commonwealth of Pennsylvania, as more specifically delineated herein.

FACTUAL ALLEGATIONS

1. Article V, § 18 of the Constitution of the Commonwealth of Pennsylvania grants to the Board the authority to determine whether there is probable cause to file formal charges against a judicial officer in this Court, and thereafter, to prosecute the case in support of such charges in this Court.
2. From March 28, 2000, to the present, Judge Wilcox has served as Magisterial District Judge for Magisterial District 42-3-01, Bradford County Pennsylvania.

Commonwealth v. DMN & Commonwealth v. CKR:

3. On December 1, 2024, Trooper Jeremy Seabridge filed a citation for summary harassment in the matter of *Commonwealth v. DMN*,¹ MJ-42301-NT-306-2024.
4. On December 1, 2024, Trooper Jeremy Seabridge filed a citation for summary harassment in the matter of *Commonwealth v. CKR*, MJ-42301-NT-307-2024.
5. DMN was the alleged victim in the matter of *Commonwealth v. CKR*, MJ-42301-NT-307-2024.
6. CKR was the alleged victim in the matter of *Commonwealth v. DMN*, MJ-42301-NT-306-2024.
7. On January 23, 2025, DMN met with Judge Wilcox regarding the pending cases.
8. DMN provided Judge Wilcox with the unopened envelope that contained CKR's citation and her citation.
9. During the January 23, 2025 discussion, Judge Wilcox scheduled to meet with DMN again on January 24, 2025, at 11:00 AM to address the two (2) pending matters.
10. During Judge Wilcox's January 23, 2025 meeting with DMN, he provided DMN with his personal cell phone number.
11. After the January 23, 2025, meeting, Judge Wilcox texted DMN details about his personal life.
12. The morning of January 24, 2025, DMN texted Judge Wilcox asking whether they should meet at a coffee shop or at his judicial office.

¹ Due to the nature of some of the allegations at Paragraphs 3-25, the Board will refer to case names and individuals by their initials throughout this Complaint.

13. Judge Wilcox responded with the following text "Meet me at the office as I want to go over the citations with you. I need to make things legitimate if you know what I mean. See you soon...."
14. On January 24, 2025, Judge Wilcox met with DMN in his office.
15. On January 24, 2025, Judge Wilcox dismissed the matter of *Commonwealth v. CKR*, MJ-42301-NT-307-2024.
16. On January 24, 2025, Judge Wilcox typed the following in the case notes for *Commonwealth v. CKR*, MJ-42301-NT-307-2024. "I spoke the victim of the crime. She stated that she did not want to pursue any charges against the defendant and vis versa. As neither party will testify the events of that day case dismissed. There is no need for the Trp to travel from his new station in Laporte to here for a case that will be dismissed. **jmw.**" (grammatical and spelling errors in original) A copy of this MDJS case entry is attached hereto as Exhibit A, made a part hereof, and incorporated herein as though set forth in full.
17. On January 24, 2025, Judge Wilcox entered the following case notes for *Commonwealth v. DMN*, MJ-42301-NT-306-2024. "The Defendant spoke to me and state that she went to the police and never thought that they would file charges against her and the other party, her boyfriend. Defendant just wanted to report the situation but wanted nothing done by law enforcement. As neither one of them wants to testify against each other on these events. Therefore, this case along with the other case are being dismissed. There is no reason for the Trp to come from Laporte to have the charges dismissed at the hearing as parties are not going to testify against each other. **jmw.**"

(Grammatical errors in original). A copy of this MDJS case entry is attached hereto as Exhibit B, made a part hereof, and incorporated herein as though set forth in full.

18. Judge Wilcox never discussed the above matters with Trooper Seabridge.
19. CKR was unaware he had been charged with a summary offense.
20. CKR was unaware he was the alleged victim of DMN's summary offense.
21. Judge Wilcox instructed his staff to get rid of DMN and CKR's files.
22. Judge Wilcox advised his staff not to discuss his actions in the DMN matter with anyone and if they did, he would know they had leaked the information.
23. Between January 23, 2025, and January 29, 2025, Judge Wilcox texted DMN numerous times. A copy of the text exchange is attached hereto as Exhibit C, made a part hereof, and incorporated herein as though set forth in full.
24. In Judge Wilcox's last text message sent at 10:23 PM on January 29, 2025, he acknowledged he would be required to recuse from any further matters involving DMN and CKR.
25. Judge Wilcox dismissed DMN's case on May 19, 2025.

Commonwealth v. Hope Michelle Short:

26. On November 4, 2022, at *Commonwealth v. Hope Michelle Short*, Judge Wilcox issued a Commitment for the following traffic offenses wherein he sentenced Ms. Short to serve a term of imprisonment of one-hundred-fifty-one (151) days from November 4, 2022, until April 4, 2023:

 - b. MJ-42301-TR-659-2021
 - c. MJ-42301-TR-660-2021

- d. MJ-42301-TR-661-2021
- e. MJ-42301-TR-662-2021

- i. MJ-42301-TR-493-2022

- 27. Judge Wilcox did not hold a payment determination hearing prior to issuing the November 4, 2022, Commitment.
- 28. On March 6, 2025, Judge Wilcox issued a second Commitment wherein he sentenced Ms. Short on the above dockets to a sentence of sixteen (16) days on March 22, 2025.
- 29. Judge Wilcox did not hold a payment determination hearing before issuing the March 6, 2025 Commitment.
- 30. Ms. Short was released on March 10, 2025, after she paid the remaining fines and costs.

31. By virtue of some or all of the conduct alleged in paragraphs 21, and 27 through 32, Judge Wilcox violated Canon 1, Rule 1.1 of the Rules Governing Standards of Conduct of Magisterial District Judges (RGSCMDJ).

32. Canon 1, Rule 1.1 states the following:

Canon 1, Rule 1.1 Compliance with the Law.

A magisterial district judge shall comply with the law, including the Rules Governing Standards of Conduct of Magisterial District Judges.

33. Judge Wilcox committed the crime of obstructing the administration of law when he instructed his staff to get rid of CKR and DMN's files.

34. Judge Wilcox failed to comply with the law when he failed to hold a payment determination hearing for Ms. Short prior to sentencing her to jail time.

Counts 3 - 6– Violation of Canon 1, Rule 1.2

35. By virtue of some or all of the conduct alleged in paragraphs 7 through 17, 21 through 25, and 29 through 32, Judge Wilcox violated Canon 1, Rule 1.2 of the RGSCMDJ.

36. Canon 1, Rule 1.2 states the following:

Canon 1, Rule 1.2 Promoting Confidence in the Judiciary.

A magisterial district judge shall act at all times in a manner that promotes public confidence in the independence, integrity, and impartiality of the judiciary, and shall avoid impropriety and the appearance of impropriety.

37. By meeting with DMN regarding her case prior to the hearing Judge Wilcox failed to promote confidence in the judiciary and avoid impropriety and the

appearance of impropriety within the meaning of Canon 1, Rule 1.2 of the RGSCMDJ.

38. By directing his staff to get rid of DMN and CKR's files, Judge Wilcox failed to promote confidence in the judiciary and avoid impropriety and the appearance of impropriety in violation of Canon 1, Rule 1.2 of the RGSCMDJ.
39. When Judge Wilcox dismissed CKR's citation after meeting with DMN, he failed to promote confidence in the judiciary and avoid impropriety and the appearance of impropriety in violation of Canon 1, Rule 1.2 of the RGSCMDJ.
40. By sentencing Ms. Short to incarceration without a payment determination hearing, Judge Wilcox failed to promote confidence in the judiciary and avoid impropriety and the appearance of impropriety in violation of Canon 1, Rule 1.2 of the RGSCMDJ.

Count 7– Violation of Canon 1, Rule 1.3

41. By virtue of some or all of the conduct alleged in paragraph 23, Judge Wilcox violated Canon 1, Rule 1.3 of the RGSCMDJ.
42. Canon 1, Rule 1.3 states the following:

Canon 1, Rule 1.3 Avoiding Abuse of the Prestige of Judicial Office.

A magisterial district judge shall not abuse the prestige of judicial office to advance the personal or economic interests of the magisterial district judge or others, or allow others to do so.

43. Judge Wilcox abused the prestige of his judicial office when he pursued a relationship with DMN.

Counts 8 -9 – Violation of Canon 2, Rule 2.2

44. By virtue of some or all of the conduct alleged in paragraphs 14 through 25 and 28 through 32, Judge Wilcox violated Canon 2, Rule 2.2 of the RGSCMDJ.

45. Canon 2, Rule 2.2 states the following:

Canon 2, Rule 2.2 Impartiality and Fairness

A magisterial district judge shall uphold and apply the law, and shall perform all duties of judicial office fairly and impartially.

46. Judge Wilcox failed to act with impartiality when he met with DMN and dismissed her and CKR's cases.

47. Judge Wilcox failed to uphold and apply the law when he sentenced Ms. Short to incarceration without a hearing as required under Rule 456 of the Pennsylvania Rules of Criminal Procedure.

Count 10 - Violation of Canon 2, Rule 2.5

48. By virtue of some or all of the conduct alleged in paragraphs 28 through 32, Judge Wilcox violated Canon 2, Rule 2.5 of the RGSCMDJ.

49. Canon 2, Rule 2.5 states the following:

Canon 2, Rule 2.5 Competence, Diligence and Cooperation

(A) A magisterial district judge shall perform judicial and administrative duties competently and diligently.

50. Judge Wilcox violated this rule when he sentenced Ms. Short to incarceration for failing to pay assessed fines without first conducting a hearing regarding her ability to pay as required under Rule 456 of the Pennsylvania Rules of Criminal Procedure.

Counts 11-13 – Violation of Canon 2, Rule 2.6

51. By virtue of some or all of the conduct alleged in paragraphs 15 through 21, and paragraphs 28 through 32, Judge Wilcox violated Canon 2, Rule 2.6 of the RGSCMDJ.

52. Canon 2, Rule 2.6 states the following:

Canon 2, Rule 2.6 Ensuring the Right to be Heard

(A) A magisterial district judge shall accord to every person or entity who has a legal interest in a proceeding, or that person or entity's lawyer or authorized representative, the right to be heard according to law.

53. Judge Wilcox violated this rule when he failed to allow Trooper Seabridge a right to be heard prior to dismissing DMN and CKR's cases.

54. Judge Wilcox violated this rule when he failed to allow CKR his right to be heard regarding his case and DMN's case where he was the alleged victim.

55. Judge Wilcox violated this rule when he failed to allow Ms. Short her right to be heard when he sentenced her to a period of incarceration without a hearing.

Count 14-15 – Violation of Canon 2, Rule 2.9

56. By virtue of some or all of the conduct alleged in paragraphs 7 through 24, Judge Wilcox violated Canon 2, Rule 2.9 of the RGSCMDJ.

57. Canon 2, Rule 2.9 states the following:

Canon 2, Rule 2.9 *Ex parte* Communications

(A) A magisterial district judge shall not initiate, permit or consider *ex parte* communications, or consider other communications made to the magisterial district judge outside the presence of the parties or their lawyers or authorized representatives, concerning a pending or impending matter...

58. Judge Wilcox violated this rule when he met with DMN on January 23, 2025, and January 24, 2025, regarding her pending case.
59. Judge Wilcox violated this rule when he met with DMN on January 23, 2025, and January 24, 2025, regarding CKR's pending case.

Count 16 – Violation of Canon 2, Rule 2.16

60. By virtue of some or all of the conducted alleged in paragraph 22, Judge Wilcox violated Canon 2, Rule 2.16 of the RGSCMDJ.
61. Canon 2, Rule 2.16 states the following:
- (B) A magisterial district judge shall not retaliate, directly or indirectly, against a person known or suspected to have assisted or cooperated with an investigation of a magisterial district judge or a lawyer.
62. Judge Wilcox violated this rule when he advised his staff not to discuss his actions in the DMN matter with anyone and if they did, he would know they had leaked the information.

Counts 17 - 24 – Violation of Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania

63. By virtue of some or all of the conduct set forth above, Judge Wilcox violated Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.
64. Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania states the following:
- Justices and judges shall not engage in any activity prohibited by law and shall not violate any canon of legal or judicial ethics prescribed by the Supreme Court. Justices of the peace shall be governed by rules or canons which shall be prescribed by the Supreme Court.
65. A violation of the RGSCMDJ constitutes an automatic derivative violation of

Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.

66. Judge Wilcox violated Canon 1, Rule 1.1.
67. Judge Wilcox violated Canon 1, Rule 1.2.
68. Judge Wilcox violated Canon 1, Rule 1.3.
69. Judge Wilcox violated Canon 2, Rule 2.2.
70. Judge Wilcox violated Canon 2, Rule 2.5.
71. Judge Wilcox violated Canon 2, Rule 2.6.
72. Judge Wilcox violated Canon 2, Rule 2.9.
73. Judge Wilcox violated Canon 2, Rule 2.16.
74. By violation of all, or some, of the Rules set forth above, Judge Wilcox violated Article V, § 17(b) of the Constitution of the Commonwealth of Pennsylvania.

Count 25– Violation of Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania

75. By virtue of some or all of the conduct set forth above, Judge Wilcox violated Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania.
76. Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania states the following:

A justice, judge or justice of the peace may be suspended, removed from office or otherwise disciplined for . . .conduct which brings the judicial office into disrepute, whether or not the conduct occurred while acting in a judicial capacity [.]
77. By engaging in the conduct set forth above, Judge Wilcox engaged in conduct that was so extreme that it brought the judicial office itself into disrepute and

thereby constitutes a violation of the Disrepute Clause of Article V, § 18(d)(1) of the Constitution of the Commonwealth of Pennsylvania.

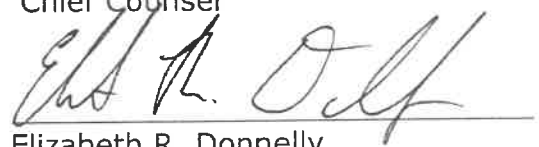
