**PETITION SETTING FORTH OBJECTIONS TO A NOMINATION
PETITION**

The undersigned Petitioner(s)/Objector(s) hereby file(s) this Petition Setting Forth Objections to a Nomination Petition, and the instant petition hereby prays and requests that the Nomination Petitions filed by and/or on behalf of Jeannette Wrobel as a candidate for the Member of Republican State Committee, Lehigh County At-Large District 39, be stricken off, voided, invalidated, and set aside.

A. Objections Pursuant to 25 P.S. §2937 of the Election Code:

1. The Petitioner/Objector is Carol M. Rieder, a registered Republican-party voter in the County of Lehigh, District 39. Petitioner currently resides 1758 33rd St., SW, Allentown, PA 18103, Township of Salisbury, County of Lehigh. The Petitioner/Objector hereby objects to the Nomination Petition filed by Jeannette Wrobel seeking the listing of Member of the Republican State Committee, Lehigh

County At-Large District 39 on the ballot. *See* 25 P.S. § 2937, and other legal authority in the Election Code.

2. Section “B” below states line-by-line challenges.

3. This Court has jurisdiction over this Petition because the nomination petition was filed with the Secretary of the Commonwealth and objections are filed with this Court pursuant to the Pennsylvania Election Code.

4. Respondent filed her nomination petition on March 10, 2026, and this Petition is filed within the objection period.

B. Objections regarding Signatures:

5. Exhibit “A” attached hereto is true and correct copy of the signatures sections of the said Nomination Petition.

6. For Member of Republican State Committee, Lehigh County District 39, the law requires that a Nomination Petition must have at least 100 valid signatures. It appears that 106 signatures were submitted.

7. Of the submitted signatures, at least 17 of them are invalid. Attached hereto and incorporated herein is a true and correct copy of the spreadsheet identifying the invalid signatures and challenge codes marked as Exhibit “B”.

8. Pages 1, Side 1, lines 5, 6 and 14 are not registered Republicans.

9. Page 2, Side 1, line 8 is not registered at that address and is illegible.

10. Page 2, Side 1, line 9 is not a registered Republican and is illegible.

11. Page 2, Side 2, lines 17, 19, 20, 23, 29 and 30 are not a registered Republicans.

12. Page 3, Side 1, line 14 name is incorrect.

13. Page 3, Side 2, lines 15, 17 and 20 are not a registered Republicans.

14. Page 4, Side 1, line 6, incorrect address.

15. Page 4, Side 1, line 9, not registered as a Republican.

16. With these line-by-line challenges in place, the Nomination Petition must be stricken and set aside.

WHEREFORE, the said undersigned Petitioner/Objector hereby requests that the said Nomination Petition filed by and/or on behalf of Jeannette Wrobel as a candidate for Member of Republican State Committee, County of Lehigh, District 39, be set aside, and her name be removed from the ballot.


