PETITION TO SET ASIDE NOMINATION PETITION

Alfred Johnson and Tameko Patterson, by and through undersigned counsel,
respectfully aver:

Jurisdiction and Standing

1. This Court has jurisdiction in election petition challenges pertaining to candidates for State Representative. See 25 P.S. §§ 2913(a), 2937.
2. Alfred Johnson is a duly qualified elector of the Democratic Party who resides at 425 Lower Swiftwater Road in Cresco, within the 115th Legislative District.
3. Tameko Patterson is a duly qualified elector of the Democratic Party who resides at 2505 Norwood Drive in East Stroudsburg, within the 115th Legislative District.
4. On or about March 10, 2026, Anna Lopez filed an affidavit, a copy of a statement of financial interest, and a petition seeking to become a

candidate for the Democratic nomination for State Representative from the 115th Legislative District in the 2026 primary election.

5. A copy of Ms. Lopez’s nomination petition as submitted to the Secretary of the Commonwealth is attached hereto as Exhibit A.

Anna Lopez Did Not File 300 Valid Signatures

6. Candidates for State Representative must file a nomination petition with 300 valid lines to be on the ballot. See 25 P.S. § 2872.1(14).
7. The nomination petition submitted by Ms. Lopez contained 52 pages, containing 512 putatively completed lines, or parts thereof, as follows:

8. Within those 512 lines are numerous lines omitted in whole or part, where lines appear later on the page. For example, on page 36, the only completed line is line 15, but as the count to reach 512, page 36 is counted as 15 lines (and lines 1-14 are challenged as LIO on Exhibit B).
9. Of the 512 lines, 280 are invalid for the reasons set forth on the spreadsheet attached hereto as Exhibit B and are objected to for those reasons.
10. Ms. Lopez, in fact, submitted only 232 valid signature lines, well short of the 300 required for a state representative candidate to appear on the primary ballot.

Anna Lopez Filed a False and Incomplete Statement of Financial Interest

11. Under the Public Official and Employee Ethics Act, 65 Pa. C.S. §§ 1101-1113 (“Ethics Act”), when a political candidate wishes to run for State Representative, the candidate must file a statement of financial interests (“SFI”) with both the State Ethics Commission and file a copy of such SFI with the nomination petition. 65 Pa. C.S. § 1104(b)(1).
12. A copy of the SFI that Ms. Lopez filed with both offices on March 10, 2026, is attached hereto as Exhibit C.

13. The Ethics Act requires the candidate to disclose certain information on the SFI, including (i) the candidate's occupation, (ii) sources of income over \$1300, and (iii) any debts or obligations incurred during the year that ever exceeding \$6500 even temporarily, and must be true and correct. *See id.* at § 1105(b)(2),(4),(5).
14. Not for the first time, Ms. Lopez asserted professional qualifications that she did not have, listing her occupation or profession as a "Business Analyst" as well as a homemaker. While every person has the right, if economically feasible, to choose to be a homemaker, apparently out of an interest to exaggerate her skills, Ms. Lopez identifies herself as a "Business Analyst."
15. However, there is no record of Ms. Lopez ever being employed as a Business Analyst nor have any skills that fit the definition of that role.
16. Her own LinkedIn profile identifies her current status is as a student at East Stroudsburg University and simultaneously asserts her only professional engagement since 2014 was with Robert Half as a placement executive on a contract basis, a profile that she updated as recently as October 2025. *See www.linkedin.com/in/anna-lopez-419932196/* (visited March 12, 2026).

17. While puffery and exaggeration are permitted on LinkedIn, it is not permitted as to the very limited and specific disclosure provisions required of candidates under the Ethics Act, an obligation that expressly applies to occupation or profession.
18. The purpose of the candidate disclosure requirement under the Ethics Act “is to inform the voters where a candidate's financial interests lie prior to election.” *In re Nom. Pet. of Littlepage*, 935 A.2d 1235, 1240 (Pa. 2006).
19. When it comes to occupation or profession, quoting a major dictionary, defined a “‘profession’ as ‘[a] paid occupation, especially one that involves prolonged training and a formal qualification,’ and assigns a principal definition to ‘occupation’ as ‘[a] job or a profession.’ A ‘job,’ in turn is defined as ‘[a] paid position of regular employment.’” *In re Nom. Pet. of Beyer*, 115 A.3d 835, 839 (Pa. 2014).
20. If Ms. Lopez is, in fact, a business analyst and was employed in 2025, then she failed to disclose her income as she claimed to have no material income at all. *See Exh. C* Sec. 10.
21. However, upon information and belief, she has never been a business analyst, or at least has not worked as one for many years – at least as long as she has been filing SFIs since 2019.

22. Simply put, if business analyst is her profession and she had a job, Ms. Lopez's SFIs are false. And if she does not have the necessary qualifications to do the job or has never worked in that job, her SFIs are false.
23. At the same time, in each of the various SFIs, she also asserts no creditors at any time in the period in an amount in excess of \$6500. While possible, the failure to disclose creditors would foreclose another explanation for her lifestyle without any income, and would also be a different form of material falsity.
24. Lying on the SFI is cause for removal under the Ethics Act's fatal defect rule. *See* 65 Pa. C.S. § 1104(b)(3) ("Failure to file the statement in accordance with the provisions of this chapter shall, in addition to any other penalties provided, be a fatal defect to a petition to appear on the ballot."); *see also Beyer*, 115 A.3d at 843.
25. An intentional and material deception makes the defect incurable. Omitting all income sources is grounds to remove a candidate for failing to act in good faith in the filing of the SFI, a decision that this Court has affirmed on multiple occasions. *See In re Nom. Pet. of Lee*, 413 C.D. 2025 (Pa. Commw. Ct. 2015), *allocatur denied*, 225 EAL 2015 (Pa. 2015).

26. For filing a SFI without any meaningful disclosure in a false and misleading manner, the Court should strike Ms. Lopez from the ballot.

WHEREFORE, Petitioners pray this Honorable Court remove Ms. Lopez as a candidate for the Democratic nomination for State Representative for the 115th Legislative District and charge all costs of this proceeding, including that of any court reporter, to Ms. Lopez.




