1. The Objection is hereby **SUSTAINED**;
2. The Nomination Petition of Mark LaVelle is hereby **STRICKEN** and set aside;
3. The Secretary of the Commonwealth shall not place Mark LaVelle’s name on the Democratic ballot for the Primary Election for Representative in the General Assembly from the 177th Legislative District; and
4. Mark LaVelle shall pay the costs of the proceedings.

PETITION TO SET ASIDE NOMINATION PETITION

Petitioners Isaac F. Slepner, Esq. and Kathy Sykes, by and through their undersigned counsel, file this Petition to Set Aside the Nomination Petition of Mark LaVelle for the Democratic Party Nomination for Representative in the General Assembly from the 177th Legislative District in the May 19, 2026 Primary Election.

PARTIES

1. Petitioner Isaac F. Slepner, Esq. is a qualified and validly registered and enrolled elector registered with the Democratic Party in Pennsylvania’s 177th Legislative District. Petitioner Slepner resides at 2731 Webb Street, Philadelphia, Pennsylvania.

2. Petitioner Kathy Sykes is a qualified and validly registered and enrolled elector registered with the Democratic Party in Pennsylvania’s 177th Legislative District. Petitioner Sykes resides at 1107 Wakeling Street, Philadelphia, Pennsylvania.

3. Respondent Al Schmidt is the Secretary of the Commonwealth, whose office address is 302 North Office Building, 401 North Street, Harrisburg, Pennsylvania.

4. Respondent Mark LaVelle (“Candidate LaVelle”), whose address is 4425 East Thompson Street, Philadelphia, Pennsylvania, filed on March 10, 2026 a Nomination Petition (the

“Nomination Petition”) seeking to be listed on the ballot for the Democratic Party nomination for Representative in the General Assembly from the 177th Legislative District in the May 19, 2026 Primary Election.

5. Candidate LaVelle was previously the Republican Party nominee for Representative in the General Assembly from the 177th Legislative District in the November 8, 2022 General Election

JURISDICTION

6. This Court has original jurisdiction over this matter pursuant to 42 Pa. C.S. § 764 and 25 P.S. § 2937.

7. The Pennsylvania Election Code governs the matters at issue in this Petition. *See generally* 25 P.S. §§ 2600 *et seq.*

FACTUAL BACKGROUND

8. On May 19, 2026, the Commonwealth of Pennsylvania will hold a Primary Election, at which registered Democratic voters in the 177th Legislative District will choose the Democratic Party’s nominee for Representative in the General Assembly.

9. Candidate LaVelle’s Nomination Petition consists of 16 pages accompanied by a Candidate’s Affidavit. Copies of the Nomination Petition are attached to this Petition to Set Aside as **Exhibit A**. Copies of Candidate LaVelle’s Candidate’s Affidavit are attached to this Petition as **Exhibit B**.

10. The Nomination Petition purportedly contains 382 signature lines (some lines have been stricken or are completely blank), but, as detailed below, there are numerous ineligible signature and defects in the signatures. Candidate LaVelle’s Nomination Petition is fatally defective.

OBJECTIONS TO NOMINATION PETITION

11. To qualify for the Democratic Party ballot for Representative in the General Assembly, a candidate must file a nomination petition containing 300 valid signatures of registered and enrolled members of the Democratic Party. 25 P.S. § 2872.1(14).

12. In addition, the Election Code specifies the requirements for circulating and signing a Nomination Petition in order for the Nomination to be valid. 25 P.S. §§ 2868, 2869.

13. The Election Code also sets forth the basis upon which the voters can challenge and object to a Nomination Petition. 25 P.S. § 2937.

14. Petitioners have reviewed Candidate LaVelle’s Nomination Petition and believe the Nomination Petition is invalid, does not comply with the Election Code, and should be set aside because Candidate LaVelle failed to obtain at least 300 valid signatures.

15. *Challenges to Individual Signature Lines.* Petitioners are challenging at least 252 invalid and ineligible signature lines out of the 382 signature lines in Candidate LaVelle’s Nomination Petition. Reducing the total signature lines in the Nomination by 252 invalid signatures results in only 130 valid signatures, well below the 300 signatures required to be listed on the ballot for the Democratic Party nomination for Representative in the General Assembly:

382	signature lines submitted

16. The spreadsheet chart required by this Court’s January 22, 2026 Standing Order, which describes with particularity and page by page, line by line, the signature lines being challenged in the Nomination Petition as ineligible or invalid is attached as **Exhibit C**.

17. Of the 252 signature lines challenged by Petitioners, 140 of the signature lines face “fatal” challenges that cannot be cured, including, for example, “Not Registered,” “Not Registered in Candidate’s Party,” “Not Registered in District,” “Not Registered on Date Signed,” or “Duplicate.” Sheets 5, 25, and 61 of Candidate Joe Hohenstein’s Nomination Petition, which contain earlier-dated signature lines duplicated in Candidate LaVelle’s Nomination Petition, are attached as **Exhibit D**.

18. These fatal challenges alone would leave Candidate LaVelle with only 242 valid signature lines, well below the 300 signatures required to be listed on the ballot for the Democratic Party nomination for Representative in the General Assembly.

19. *Defective Circulator Statements.* In addition to bases for concluding that individual signature lines are invalid, the Circulator Statements on pages 5, 7, 8, 9, 14, 15, and 16 are defective.

20. In particular, pages 5, 14, 15, and 16 do not contain the information required by the Election Code. 25 P.S. § 2869.

21. For pages 5, 14, 15, and 16, Petitioners are without knowledge or information sufficient to form a belief as to whether the circulators (Candidate LaVelle and Denise Shapley Hasson) signed their Circulator Statements before or after voters allegedly completed the signature lines on those sheets.

22. In addition, Denise Shapley Hasson’s Circulator Statements on pages 14, 15, and 16 are further defective because, upon information and belief, Denise Shapley Hasson is not a qualified elector of the Commonwealth and therefore is ineligible to circulate nomination petitions. 25 P.S. § 2869.

23. Accordingly, Denise Shapley Hasson’s Circulator Statements on pages 14, 15, and

16 are false because she knew or should have known when she signed that she was not a qualified elector of the Commonwealth.

24. Finally, upon information and belief, Petitioners aver that Candidate LaVelle did not circulate pages 7, 8, and 9 to the voters who allegedly signed those pages.

25. Candidate LaVelle therefore lacks the personal knowledge required to validate pages 7, 8, and 9, which therefore must be stricken.

26. This Court should set aside Candidate LaVelle's Nomination Petition because Candidate LaVelle failed to obtain at least 300 valid signatures of registered and enrolled members of the Democratic Party required to qualify for the Democratic Party ballot for Representative in the General Assembly.

WHEREFORE, the Petitioner prays this Honorable Court enter an Order as follows:

A. Sustaining the objections of the Petitioner to the Nomination Petition of Mark LaVelle;

B. Declaring that Mark LaVelle does not have the requisite number of valid signatures as required under the Election Code to have his name placed on the ballot for the Democratic Party nomination for Representative in the General Assembly from the 177th Legislative District;

C. Setting aside the Nomination Petition of Mark LaVelle;

D. Directing the Secretary of the Commonwealth to set aside the Nomination Petition of Mark LaVelle and further directing them not to place Mark LaVelle's name on the Democratic ballot for the Primary Election for Representative in the General Assembly from the 177th Legislative District;

E. Ordering Mark LaVelle to pay costs of the proceedings, including attorney fees, as the Court deems just, pursuant to 42 Pa. C.S. § 2503; and

F. Granting such further relief as the Court deems necessary and just.

Note: This list of abbreviations for the various grounds to object to a signature is also referred to as the "challenge codes key."

3. The objection petition shall clearly state the number of signature lines challenged as well as the total number of completed signature lines on the face of the nomination petitions or papers.
4. Any other objections, e.g., to circulator statements, candidate affidavits, etc., must be clearly and separately stated in the objection petition.
5. If filing the objection petition in paper format:
 - a. Objector shall attach to the objection petition as an exhibit a printed copy of the spreadsheet printed on 8 ½ x 14 inch paper, with all grid lines showing and column headings appearing on each printed sheet, and a printed copy of the challenge codes key.

- b. In addition, Objector shall file two separate digital media devices (CD or USB flash drive), each containing an electronic version of the spreadsheet and the challenge codes key. The electronic version of the spreadsheets on the each digital media devices must be enabled for editing by the Court, and may **not** be read-only or password protected.

6. If filing the objection petition electronically:

- a. Along with the electronically filed objection petition, Objector shall file as an exhibit an electronic (PDF) version of the spreadsheet with all grid lines showing and column headings appearing on each sheet, and an electronic (PDF) version of the challenge codes key.
- b. **Within two days** of submission of filing the objection petition and spreadsheet, Objector shall submit to the Court two paper copies of the electronically filed objection petition and spreadsheet **and** two separate digital media devices (CD or USB flash drive), each containing an electronic version of the spreadsheet and the challenge codes key. The electronic version of the spreadsheet on the each digital media device must be enabled for editing by the Court, and may **not** be read-only or password protected. **No changes may be made to the original spreadsheet filed electronically with the Court.**
