PETITION TO SET ASIDE NOMINATION PETITION

TO THE HONORABLE JUDGES OF THE COMMONWEALTH COURT:

The undersigned Petitioner/Objector hereby files this Petition setting forth objections to a Nomination Petition, and the instant Petition hereby prays and requests that the Nomination Petition(s) filed by and/or on behalf of Hiel E. Bartlett as a Candidate for Member of the Republican State Committee McKean County (District 42) be stricken off, voided, invalidated and set aside.

1. The Petitioner/Objector is Patrick Warnick, a registered Republican/Party voter in McKean County (District 42). The Petitioner/Objector currently resides at 306 Harrison Street, Port Allegany, PA 16743. The Petitioner/Objector is a candidate for the Office of Member of the Republican State Committee McKean County (District 42).

2. The Respondent is Hiel E. Bartlett. Mr. Bartlett, according to his Candidate's Affidavit, resides at 83 Crookerhouse Lane, Bradford, PA 16701. Mr. Bartlett is a Candidate who filed a Nomination Petition(s) seeking placement on the May 19, 2026 Republic Primary Ballot for the office of Member of the Republican State Committee, McKean County (District 42).

3. This Court has jurisdiction over this Petition because the Nomination Petition(s) of Mr. Bartlett were filed with the Secretary of the Commonwealth and objections are filed with this

Court pursuant to The Election Code in the Court's Administrative Orders governing election objections.

4. The Respondent filed his Nominating Petition(s) on or before March 10, 2026.

Accordingly, this Petition is filed within the objection period as set forth by the Election Code and applicable Court Orders.

5. Attached hereto as Exhibit A are the Nominating Petition(s) filed by and/or on behalf of Mr. Bartlett and his Candidate's Affidavit. The Petitions consist of fourteen (14) pages and one hundred twenty (120) names of purported registered Republican Electors.

6. For the office of Member of the Republican State Committee McKean County (District 42), the law requires that a nomination petition must have at least one hundred (100) valid signatures.

7. Exhibit B attached hereto states the line by line challenges to the Petition(s) filed by or on behalf of Mr. Bartlett. A total of fifty-nine (59) names are challenged as set forth on Exhibit B. If those challenges are sustained, Mr. Bartlett will be left with sixty-one (61) valid registered Republican electors who have signed his Petition. Accordingly, as mentioned above, his Petition to be placed on the ballot for the office of Member of the Republican State Committee McKean County (District 42) should be stricken off, voided, invalidated, and set aside.

8. Attached hereto and incorporated herein as Exhibit C is a true and correct copy of the spreadsheet identifying the invalid signatures and challenge codes. This spreadsheet reiterates and summarizes the information contained in this Petition and in Exhibit B.

WHEREFORE, the undersigned Petitioner/Objector hereby requests that the said Nominating Petition(s) filed by and/or on behalf of Hiel E. Bartlett as a Candidate for Member of
