**PETITION TO SET ASIDE NOMINATION PETITION**

TO THE HONORABLE JUDGES OF THE  
COMMONWEALTH COURT OF PENNSYLVANIA:

Petitioner, Ronald Aldom, by filing this Petition, respectfully states as follows:

I. PARTIES

1. Petitioner Ronald Aldom is an adult individual residing at 1468 Gebhart Way, Hidden Valley, Pennsylvania 15502, and is a qualified elector of the Commonwealth of Pennsylvania.
2. Petitioner is a registered and enrolled member of the Republican Party and resides within the Senatorial District for which Respondent seeks nomination.
3. Respondent Harry Young Cochran resides at 29B Lawn Ave, Connellsville, PA 15425, and filed nomination petitions seeking placement on the Republican Primary ballot for the office of State Senator for the 32<sup>nd</sup> Senatorial District.

II. JURISDICTION & TIMELINESS

4. This Court has original jurisdiction over this matter pursuant to Section 977 of the Pennsylvania Election Code, 25 P.S. § 2937.
5. Respondent filed nomination petitions with the Secretary of the Commonwealth on or before the filing deadline of March 10, 2026.
6. This Petition is filed within the statutory objection period, which expires March 17, 2026.

### III. FACTUAL ALLEGATIONS

7. Respondent filed nomination petitions containing 645 signature lines.  
Pursuant to the Pennsylvania Election Code, a candidate for the office of State Senator must submit at least five hundred (500) valid signatures of registered and enrolled members of the candidate's political party. 25 P.S. § 2872.1 (13).
8. Petitioner identified numerous defective signature lines which are legally invalid and must be stricken.
9. Petitioner's objections to individual signatures are detailed in the spreadsheet attached as Exhibit "A."
10. Petitioner identified at least one hundred five (105) signature lines where the elector signed the nomination petition after the date on which the circulator had already executed the circulator's affidavit. Because the circulator's affidavit attests that the signatures were obtained prior to execution of the statement, signatures obtained after the circulator signed the affidavit are invalid and must be stricken.
11. As the Commonwealth Court held in *In re Nomination Papers of Mann*, 944 A.2d 119, 126 (Pa. Commw. Ct. 2008):

Sworn affidavits ensure the legitimacy of information crucial to the election process. *In re Nomination Petition of Cianfrani*, 467 Pa. 491, 494, 359 A.2d 383, 384 (1976). A notary's certificate of acknowledgement is *prima facie* evidence of the due execution of the instrument. *Sheaffer v. Baeringer*, 346 Pa. 32, 36, 29 A.2d 697, 699 (1943). However, any signatures obtained after the circulator and notary completed the circulator's affidavit are invalid. *In re Nomination Paper of Nader*, 865 A.2d 8, 98 (Pa. Cmwlth. 2004). The Election Code will be strictly enforced to prevent fraud. *In re Petition of Cioppa*, 533

Pa. 564, 570, 626 A.2d 146, 149 (1993). "It is clear that the provisions of the election law regulating nomination papers and affidavits are not mere technicalities but necessary measures to prevent fraud and preserve the integrity of the election process." *In re Nomination Papers of Carlson*, 60 Pa. Commw. 170, 430 A.2d 1210, 1212 (Pa. Cmwlth. 1981).

12. Petitioner further identified five (5) signature lines containing cross outs, alterations, or other defects that render the information unreliable or incomplete.
13. Petitioner also identified forty-six (46) individuals who signed Respondent's nomination petitions but are not registered and enrolled members of the Republican Party, the political party whose nomination Respondent seeks.
14. Petitioner also identified twenty-seven (27) individuals whose names could not be located in voter registration records and who therefore appear to be not registered electors.
15. Signers of a nomination petition must be registered and enrolled electors of the same political party as the candidate. *See* 25 P.S. § 2868.
16. Petitioner further identified eighteen (18) duplicate signature lines, where individuals signed Respondent's nomination petitions more than once. Only one signature per elector may be counted, and any duplicate signatures must be stricken. "[e]ach signer of a nomination petition shall sign but one such petition for each office to be filled." § 2868.
17. These categories of defective signatures represent unique challenges that do not overlap and therefore constitute at least two hundred one (201) invalid signature lines.
18. After striking these invalid signatures, Respondent would have no more than four hundred forty-four (444) valid signatures, which is fewer than the five hundred (500) signatures required by law.
19. "If the court shall find that said nomination petition or paper... does not contain a sufficient number of genuine signatures of electors entitled to sign the same under the provisions of this act, or was not filed by persons entitled to file the same, it shall be set aside." 25 Pa. Stat. Ann. § 2937.

WHEREFORE, Petitioner respectfully requests that this Honorable Court:

- A. Schedule this matter for hearing in accordance with the Court's election objection procedures;
- B. Enter an Order setting aside Respondent's Nomination Petition and directing that Respondent's name not appear on the Republican Primary ballot for Senator in the General Assembly, 32nd Senatorial District; and
- C. Grant such other relief as the Court deems just and proper.



## ELECTION SPREADSHEET DIRECTIONS

By order of the Commonwealth Court of Pennsylvania, all Petitions to Set Aside Nomination Petitions or Papers (objection petitions) must be filed either in paper format (original and one copy) or electronically by PACFile (the Pennsylvania appellate court electronic filing system). When individual elector signatures are challenged, the objection petition must be accompanied by a spreadsheet as specified in the Court's order and the directions below.

1. The objection petition shall specify the objections to individual signature lines in nomination petitions or papers and these shall be set forth in this spreadsheet .
2. Spreadsheet columns shall include, for each challenged signature line: page number, line number, county, and the reason or reasons for each objection. The spreadsheet shall designate the grounds for objection using the following abbreviations:

NR =	Not Registered
NRA =	Not Registered At Address
