**PETITION TO SET ASIDE NOMINATION PETITION OF RESPONDENT,
MALCOLM KENYATTA**

Petitioner, Naderah Griffin, by and through counsel, in support of the Petition to set Aside Nomination Petition of Malcolm Kenyatta, and have the said Respondent's name removed from the official ballot respectfully avers as follows:

1. The Petitioner, Naderah Griffin, is a duly qualified elector registered as a Democrat in the 181st Legislative District with 1731 Francis St., Philadelphia, Pa. 19130.
2. The Respondent, Malcolm Kenyatta, is a putative candidate and is the above referenced Democratic Candidate for the General Assembly in the 181st Legislative District whose nomination petition, documents and papers are challenged as non-conforming and filed with multiple fatal defects and errors.
3. On or approximately 18 February 2026, the Respondent, Malcolm Kenyatta, filed a Candidate Affidavit and Nomination Petitions with the Commonwealth of Pennsylvania Department of State. A copy of which is attached as **Exhibit A**.
4. For the reasons set forth in greater detail as set forth in the attached **Exhibit B**, the Candidate's Nomination Petition (s) fails to contain the required number of properly

ascribed signatures as well as other fatal and disqualifying defects.

5. The Candidate has submitted five hundred twenty-nine (529) signature lines; Three hundred fifty-seven (357) of these lines are challenged for not neither complying with nor following the requirements of the Pennsylvania Election Code, with an overwhelming number of purported *signors* not registered in the 181st District and otherwise not legally permitted to sign the nominating petitions of Respondent, Malcolm Kenyatta, for the office of State Representative in the primary election.

6. Additionally, the Respondent-Candidate's Nomination Petitions, papers and certifications contain various circulator defects including lack of dates and a signature before, that is specifically the circulator variously did not date their circulator section, here there are four (4) pages **not** dated (an additional 101 signatures are therefore disqualified and unlawful); further, another circulator's signature on a page of signatures is dated **PRIOR TO** the date of one (1) of the signatures was purportedly dated therefore invalidating ALL fifteen (15) signatures on that page.

7. The Respondent's Nomination Petition (s) therefore fails to conform and are fatally defective pursuant to the requirements of the Pennsylvania Election Code, 25 P.S. §§2867 et seq., cannot be amended and must be set aside and the Respondent's-Candidate's name, Malcolm Kenyatta, cannot be lawfully and/or legally placed on the official ballot. The Respondent-Candidate, Malcolm Kenyatta, has not submitted the requisite and legally required three hundred (300) legally valid and required signatures from registered Democrats in the District.

8. Section 977 of the Pennsylvania Election Code, 25 P.S. §§ 2937, provides that a court shall set aside nomination petitions which are defective.

9. The Respondent-Candidate submitted a Candidate's Affidavit that was neither notarized nor a Candidate's Unsworn Declaration In Lieu of Notarization as required by law,

that is, **Act 2020-15** to Be Attached to Candidate's Affidavit Where Notarized Statement Is Not Available.

10. Under Pennsylvania law, a Candidate's Affidavit that is neither notarized nor contains an unsworn declaration is a fatal defect that cannot be amended after the filing deadline. See *In Re Nominating Petition of Berg*, 178 A.3d 255.

11. The Respondent-Candidate's Affidavit therefore fails to conform to the requirements of the Pennsylvania Election Code. Pennsylvania law provides that a Court must set aside the Candidate's defective Candidate Affidavit and the Candidate's name must not be placed on the official ballot. The Respondent-Candidate, Malcolm Kenyatta, has not submitted or met the requirements for a valid Candidate of Affidavit, such that his name must not be on the ballot.

12. Petitioner's **EXHIBIT D** is the specific objection EXCEL spreadsheet;

13. Petitioner's **EXHIBIT E** is the challenge codes.

14. Respondent-Candidate, Malcolm Kenyatta, intentionally and with purposeful intent listed a middle initial on his Statement of Financial Interest, but omitted a middle name and/or middle initial on his Candidate of Affidavit. The two documents lack consistency. This was intended to provide a quantum of plausible deniability and could be used to purport to identify two different people, one with a middle name and one without a middle name or not utilizing a middle initial, or one can simply have no middle name and/or initial. See **Exhibit C**.

WHEREFORE, Petitioner, Naderah Griffin, respectfully requests that the Honorable Court:

(a) Set aside the Nomination Petition of Malcolm Kenyatta;

(b) Order that Respondent's name, Malcolm Kenyatta, not be printed upon the official ballot; and

(c) Grant such other relief as is just and appropriate under the circumstances.
