PETITION TO SET ASIDE NOMINATION PETITION

Petitioners Michael Herman and Lloyd Randall Faulkner, by and through counsel, respectfully aver as follows:

1. Petitioners are duly qualified electors registered in the 143rd Legislative District.

2. The Respondent is the above-referenced Forward Independent candidate for the General Assembly in the 143rd Legislative District in upper Bucks County.

3. Respondent filed his nomination papers on August 3, 2026. They are attached as Exhibit A to this Petition.

Challenge 1: Insufficient Signatures

4. For the reasons set forth in greater detail in the attached Exhibit B, the Candidate's Nomination Papers fail to contain the required number of properly ascribed signatures.

5. The candidate has **submitted 667 signature lines; 269 of these lines are challenged** for not being in compliance with the requirements of the Election Code. Under state law, the Candidate was required to submit **488 valid signatures**.

6. Among other defects, Pages 2, 5, and 6 of the nomination papers are objected to because the Candidate signed them as circulator without having circulated them; each page reflects signatures gathered at various polling places at the primary election held on Tuesday, May 19, 2026, and persons other than the Candidate were observed circulating these pages on his behalf those dates.

7. Because the Candidate failed to submit a sufficient number of signatures, the nomination papers must be set aside.

Challenge 2: Political Body Name

8. Even if the Candidate had submitted a sufficient number of lawful signatures, his filing was prohibited by 25 P.S. §2912, which states in its relevant part:

No words shall be used in any nomination paper to designate the name or appellation of the political body represented by the candidates named in such nomination paper which are identical with or deceptively similar to the words used for a like purpose by any existing political party as defined by section 801 of this act, or which contain part of the name or an abbreviation of the name or part of the name of any existing political party; **nor shall any words be used in any nomination paper to designate the name or appellation of the political body represented by the candidate's name in such nomination paper** which are identical with or deceptively similar to the words used for a like purpose by any political body which has already filed nomination papers for the same office nor **which contain part of the name or an abbreviation of the name or part of the name of a political body which has already filed nomination papers for the same office.**

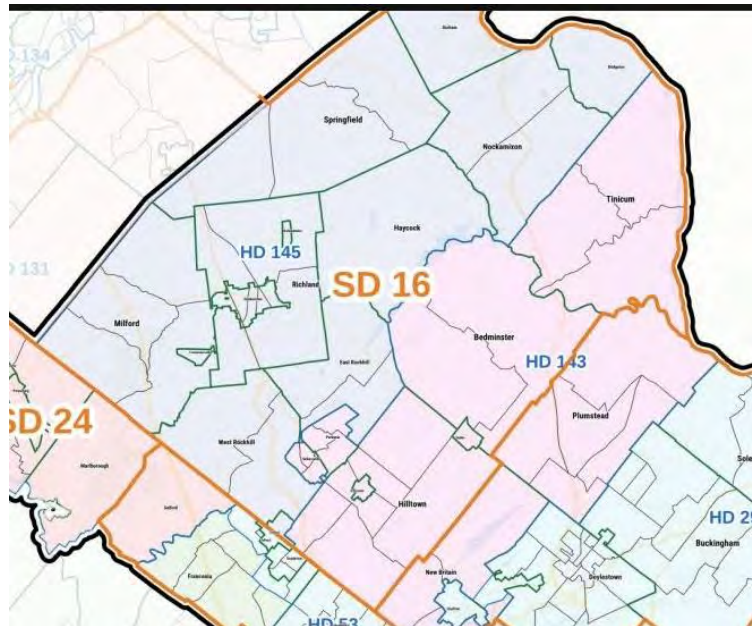

9. On July 28, 2026, Rebecca Catherine Prendergrast filed nomination papers in the adjacent 145th Legislative District in upper Bucks County as the candidate for the Independent Party, a political body.

10. As previously noted, Gambino did not file until August 3, 2026.

11. Because the Independent Party had already filed nomination papers for the same office—State House of Representatives—Gambino could not lawfully include “Independent” as part of the name of his political body.

12. Moreover, these districts border each other. The risk of voter confusion in these adjacent districts is considerable if Gambino is permitted to employ a political body name which he is not legally permitted to use.



13. Section 977 of the Election Code, 25 P.S. §2937, provides that a court shall set aside nomination papers which are defective.

14. Petitioner respectfully reserves the right to add such additional objections as are appropriate at the time of hearing.
