**PER CURIAM**

**AND NOW**, this 13<sup>th</sup> day of December, 2002, upon consideration of the Petition to Reestablish the Magisterial Districts of the 23<sup>rd</sup> Judicial District (Berks County) of the Commonwealth of Pennsylvania, it is hereby ORDERED AND DECREED that the Petition, which provides for the realignment of Magisterial Districts 23-3-01 and 23-3-03, within Berks County, to be effective January 6, 2003, is granted; and that the Petition, which also provides for the reestablishment of Magisterial Districts 23-1-01, 23-1-02, 23-1-03, 23-1-04, 23-1-05, 23-1-06, 23-2-01, 23-2-02, 23-2-03, 23-2-04, 23-3-02, 23-3-04, 23-3-05, 23-3-06, 23-3-07 and 23-3-09, within Berks County, as they currently exist, to be effective immediately, is granted.
