ORDER

PER CURIAM

AND NOW, this 13th day of December, 2002, upon consideration of the Petition to Reestablish the Magisterial Districts of the 39th Judicial District (Franklin/ Fulton County) of the Commonwealth of Pennsylvania, it is hereby ORDERED AND DECREED that the Petition, which, provides for the addition of Magisterial District 39-3-07, within Franklin County, to be effective January 5, 2004, is granted. The newly created vacancy is to be filled in the municipal election of 2003. It is further ORDERED AND DECREED that the Petition, which provides for the realignment of Magisterial Districts 39-2-01, 39-3-02, 39-3-03 and 39-3-04, within Franklin County, effective January 5, 2004, is granted; and that the Petition, which provides for the reestablishment of Magisterial Districts 39-3-05 and 39-3-06 as they currently exist, effective immediately, is granted; and that the Petition, which also provides for the reestablishment of Magisterial Districts 39-4-01, 39-4-02 and 39-4-03, within Fulton County, as they currently exist, to be effective immediately, is granted.
