**ORDER**

**PER CURIAM**

**AND NOW**, this 13<sup>th</sup> day of December, 2002, upon consideration of the Petition to Reestablish the Magisterial Districts of the 31<sup>st</sup> Judicial District (Lehigh County) of the Commonwealth of Pennsylvania, it is hereby ORDERED AND DECREED that the Petition, which provides for the realignment of Magisterial Districts 31-2-03 and 31-3-02, within Lehigh County, to be effective January 6, 2003, is granted; and that the Petition, which also provides for the reestablishment of Magisterial Districts 31-1-01, 31-1-02, 31-1-03, 31-1-04, 31-1-05, 31-1-06, 31-1-07, 31-1-08, 31-2-01, 31-2-02, 31-3-01 and 31-3-03, within Lehigh County, as they currently exist, to be effective immediately, is granted.
