AMENDED ORDER

PER CURIAM

AND NOW, this 23rd day of December, 2002, upon consideration of the Petition to Reestablish the Magisterial Districts of the 10th Judicial District (Westmoreland County) of the Commonwealth of Pennsylvania, it is hereby ORDERED AND DECREED that the Petition, which provides for the elimination of Magisterial District 10-02-04, within Westmoreland County, to be effective January 5, 2004, is granted; and that the Petition, which provides for the realignment of Magisterial Districts 10-2-09, 10-2-06, and 10-03-10 within Westmoreland County, to be effective January 5, 2004, is granted. It is FURTHER ORDERED that the realignment of Magisterial Districts 10-2-01, 10-2-10, 10-3-02, 10-3-05, 10-3-09, and 10-3-11, within Westmoreland County, to be effective January 6, 2003, is granted; and that the Petition, which also provides for the reestablishment of Magisterial Districts 10-1-01, 10-1-03, 10-1-04, 10-1-05, 10-2-02, 10-2-03, 10-2-08, 10-3-01 and 10-3-08, within Westmoreland County, as they currently exist, to be effective immediately, is granted.
