
MOTION OF THE RESPONDENT, ANGELES ROCA,  
TO STAY THE REMOVAL ORDER DATED DECEMBER 16, 2016 OF THE COURT  
OF JUDICIAL DISCIPLINE ORDERING HER REMOVAL FROM JUICIAL OFFICE  
AND TO ALLOW MEDICAL BENEFITS TO CONTINUE PENDING THE APPEAL

The Respondent, Angeles Roca, by and through her counsel, Samuel C. Stretton, Esquire, respectfully requests this Honorable Court stay the removal Order dated December 16, 2016 and allow medical benefits to continue pending the appeal for the following reasons:

1. On December 16, 2016, the Court of Judicial Discipline, by Order removed Angeles Roca.
2. Mr. Stretton has filed an appeal to the Pennsylvania Supreme Court on the sanction issue.
3. Angeles Roca, although her pay was suspended, was still receiving her medical benefits.
