

RESIGNATION
UNDER PA.R.D.E. 215

John McDanel ("Respondent"), hereby tenders his unconditional resignation from the practice of law in the Commonwealth of Pennsylvania in conformity with Pa.R.D.E. 215 ("Enforcement Rules"), and further states as follows:

1. Respondent is an attorney admitted in the Commonwealth of Pennsylvania, having been admitted to the bar in December 1987. His registration number is 50867.
2. Respondent desires to submit his resignation as a member of said bar.
3. Respondent's resignation is freely and voluntarily rendered; he is not being subjected to coercion or duress and he is fully aware of the implications of submitting this resignation.

4. Respondent acknowledges that he is fully aware of his right to consult and employ counsel to represent him in the instant proceeding. Respondent has retained, consulted with, and acted upon the advice of counsel Patrick O'Connell, Esquire, in connection with his decision to execute the within resignation.

5. Respondent is aware that there is presently pending an investigation into allegations that he has engaged in misconduct, as more fully set forth in the Petition for Discipline, filed May 5, 2025. A true and correct copy of the Petition for Discipline is attached hereto and incorporated herein as "Exhibit A."

6. Respondent acknowledges that the material facts set forth in the aforementioned Exhibit A are true.

7. Respondent is submitting the within resignation because he knows that he could not successfully defend himself against the charges of professional misconduct set forth in the attached Exhibit A.

8. Respondent is fully aware that the submission of this Resignation Statement is irrevocable and that he can only apply for reinstatement to the practice of law pursuant to the provisions of Enforcement Rule 218(b) and (c).

9. Respondent is aware that pursuant to Enforcement Rule 215(c), the fact that he has tendered this resignation shall become a matter of public record immediately upon delivery of the resignation statement to Disciplinary Counsel or the Disciplinary Board Prothonotary.


10. Upon entry of the order disbaring Respondent on consent, he will promptly comply with the notice, withdrawal, resignation, trust accounting, and cease-and-desist provisions of Enforcement Rule 217(a)-(d).

11. After entry of the order disbaring Respondent on consent, he will file a verified statement of compliance, as required by Enforcement Rule 217(e)(1).

12. Respondent is aware that the waiting period for eligibility to apply for reinstatement to the practice of law under Enforcement Rule 218(b) shall not begin until he files the verified statement of compliance required by Enforcement Rule 217(e)(1), and if the order of disbarment contains a provision that makes the disbarment retroactive to an earlier date, then the waiting period will be deemed to have begun on that earlier date.

It is understood that the statements made herein are subject to the penalties of 18 Pa. C.S.A. §4904 (relating to unsworn falsification to authorities).

PETITION FOR DISCIPLINE

Petitioner, Office of Disciplinary Counsel ("ODC"), by Thomas J. Farrell, Esquire, Chief Disciplinary Counsel, and Kristin A. Wells, Esquire, Disciplinary Counsel, files the within Petition for Discipline and charges Respondent, John McDanel, with professional misconduct in violation of the Rules of Professional Conduct ("RPC"), as follows:

1. ODC, whose principal office is located at Pennsylvania Judicial Center, Suite 2700, 601 Commonwealth Avenue, Harrisburg, PA 17106-2485, is invested, pursuant to Pa.R.D.E. 207, with the power and duty to investigate all matters involving alleged misconduct of any attorney admitted to practice law in the Commonwealth of Pennsylvania and to prosecute all disciplinary proceedings brought in accordance with the various provisions of said Rules of Disciplinary Enforcement.

2. Respondent, John McDanel, was born in March 1963, and was admitted to practice law in the Commonwealth of Pennsylvania in December 1987. Respondent's Attorney Registration No. is 50867. His office address on file with Attorney Registration is McDanel Law Firm, 107 Rear E 2nd Street, Berwick, Pennsylvania 18603.

3. Respondent is currently on active status.

4. Respondent is the subject of investigation based on his inappropriate sexual communications with a client in violation of RPC 1.8(j) via RPC 8.4(a) and his attempts

to destroy evidence of such communications, in violation of RPC 8.4(c).

CHARGE

5. Between 2013 and 2024, Respondent represented K.L. in various criminal matters, including those in which she was charged with:

- a. theft and receiving stolen property;
- b. driving under the influence, child endangerment, and related offenses; and
- c. conspiracy to endanger the welfare of a child, conspiracy to commit aggravated assault, and a related Child and Youth Services matter.

6. Between 2013 and 2014, Respondent's representation of K.L. was in his role as Assistant Public Defender for Montour County; since 2014, Respondent has been either court-appointed or represented K.L. on a *pro bono* basis.

7. As K.L.'s attorney, Respondent held a position of trust and power.

8. Respondent was aware throughout his representation of K.L. that she was particularly vulnerable in that she:

- a. had a financial hardship;
- b. suffered from mental illness;
- c. had been addicted to drugs since at least 2021;
- d. was involved in a sex trafficking ring; and
- e. experienced the loss of her husband by suicide in 2011.

9. Prior to their attorney-client relationship, Respondent and K.L. did not have a consensual sexual relationship.

10. During the representation, Respondent made comments to K.L. regarding her physical appearance, and specifically her breasts and buttocks.

11. Between November 2023 and February 2024, Respondent communicated with K.L. *via* text message.

12. A true and correct copy of Respondent's text message communications with K.L. are attached hereto as Exhibit A.

13. On the following dates, Respondent sent K.L. suggestive and sexually explicit text messages:

- a. November 9, 2023 (Exhibit A at Bates 00001);
- b. November 10, 2023 (Exhibit A at Bates 00003-00005);
- c. November 15, 2023 (Exhibit A at Bates 00006-00008 and 00013-00015);
- d. November 27-28, 2023 (Exhibit A at Bates 00018);
- e. November 30, 2023 (Exhibit A at Bates 00019);
- f. December 1-6, 2023 (Exhibit A at Bates 00021-00024);
- g. December 11, 2023 (Exhibit A at Bates 00025-00027);
- h. December 14 and 19-21, 2023 (Exhibit A at Bates 00031-00044);
- i. January 1-2 and 18-24, 2024 (Exhibit A at Bates 00045-00050);
- j. January 26-28, 2024 (Exhibit A at Bates 00052-00057); and
- k. February 1-11, 2024 (Exhibit A at Bates 00058-00072).

14. Respondent sent the suggestive and sexually explicit text messages K.L. in an attempt to elicit an intimate sexual relationship with her.

15. Respondent was aware that his text messages to K.L. were inappropriate.

16. Respondent repeatedly encouraged K.L. to delete his sexually explicit text messages from her phone, including on the following dates:

- a. January 2, 2024 (Exhibit A at Bates 000045);
- b. January 25, 2024 (Exhibit A at Bates 000052); and
- c. January 28, 2024 (Exhibit A at Bates 000055).

17. Respondent encouraged K.L. to delete his sexually explicit text messages in an attempt to conceal his misconduct and avoid professional discipline.

RULE VIOLATIONS

18. By his conduct as alleged in paragraphs 5 through 17, above, Respondent has violated the following Rules of Professional Conduct:

- a. RPC 1.8(j), which prohibits lawyers from having sexual relations with clients unless a consensual relationship existed between them when the lawyer-client relationship commenced, specifically and *via* RPC 8.4(a), which provides, in pertinent part, that it is professional misconduct for a lawyer to attempt to violate the Rules of Professional Conduct;
- b. RPC 8.4(c), which, in pertinent part, prohibits lawyers from engaging in conduct involving dishonesty, fraud, deceit, or misrepresentation..

WHEREFORE, Petitioner prays that your Honorable Board appoint, pursuant to Pa.R.D.E. 205, a Hearing Committee to hear testimony and receive evidence in support of the foregoing charges and upon completion of said hearing to make such findings of fact, conclusions of law, and recommendations for disciplinary action as it may deem appropriate.
