AND NOW, this 21st day of February, 2024, the matter before the Court having become moot, as the subject subpoena became unenforceable upon the General Assembly's adjournment *sine die* of the 2021-2022 legislative session, the order of the Commonwealth Court, dated February 9, 2023, is VACATED, and the appeal before this Court is DISMISSED. The application for relief filed by Appellants Roberta Winters, Nichita Sandur, Kathy Foster-Sandru, Robin Roberts, Kierstyn Zolfo, Michael Zolfo, Phyllis Hilley, Ben Bowens, the League of Women Voters of Pennsylvania, Common Cause Pennsylvania and Make the Road Pennsylvania (collectively "Voter-Intervenors") in the matter docketed at 28 MAP 2023, entitled Unopposed Application for Leave to "re-File" Voter-Intervenors' Reply Brief, is hereby DENIED, given that this Court has dismissed the underlying appeal.
