**CONCURRING AND DISSENTING STATEMENT**

**JUSTICE BROBSON**

Petitioner the County of Chester Board of Elections (Board) has raised an important issue worthy of this Court's consideration, namely the proper construction and application of Sections 1701 and 1703 of the Election Code, 25 P.S. §§ 3261, 3263, relating to the initiation of a recount upon the petition of qualified electors. I thus agree with the majority's decision to grant the Petition for Allowance of Appeal. I, however, respectfully disagree with the majority's decision to dispose of the merits summarily through a *per curiam* order vacating the Commonwealth Court's decision below based solely on the contents of the Board's Petition. By doing so, this Court has deprived Respondents, who prevailed below, the opportunity to be heard by this Court on the Board's challenge to the Commonwealth Court's unpublished, single-judge Memorandum Opinion and Order. As I would have given the parties the opportunity to brief fully and argue their respective positions before this Court, I dissent from the majority's summary disposition.

Justice Mundy joins this concurring and dissenting statement.
