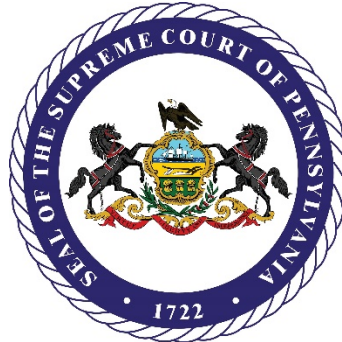


## Notice Regarding the Supreme Court of Pennsylvania's December 2021 Oral Argument Session
