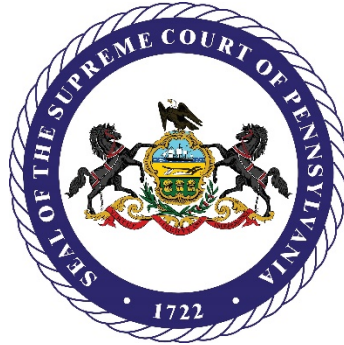


Notice Regarding the Supreme Court of Pennsylvania's March 2022 Oral Argument Session
