


## Notice Regarding the Supreme Court of Pennsylvania's May 2022 Oral Argument Session

Oral arguments will be held in person in the courtroom at Old City Hall (Chestnut Street at 5th Street) in the Independence National Historical Park on May 18 beginning at 10:00 a.m. Attendance is limited to the available very-limited seating in the courtroom. All of those interested in viewing argument are invited to watch a video livestream of arguments on <https://pcntv.com/> or <https://youtu.be/xUSVMYdnVfQ>.

**Counsel** shall not attend oral argument if they:

Are experiencing any symptoms of COVID-19 (fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea).

Have tested positive for COVID-19 within the past 5 days or are currently awaiting the results of a test, have been directed to isolate by a medical professional, or have had close contact with a person who has been diagnosed with COVID-19 within the past 5 days.

Arguing counsel shall notify the Court Crier, Brian Minner ((717) 412-5630 or [brian.minner@pacourts.us](mailto:brian.minner@pacourts.us)), if they display any symptoms of COVID-19, or test positive for COVID-19, within 5 days after oral argument.
