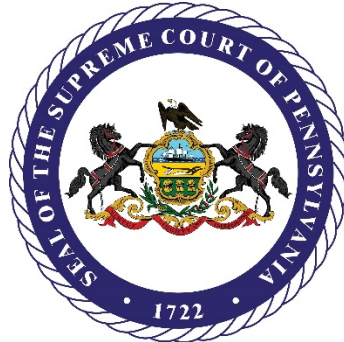


## Notice Regarding the Supreme Court of Pennsylvania's November 2022 Oral Argument Session

Oral arguments will be held in person in the Supreme Court's Harrisburg courtroom and audio of arguments will be livestreamed at [www.youtube.com/c/supremectofpaofficial](http://www.youtube.com/c/supremectofpaofficial).

**Masks will be optional** for all of those in attendance.

Persons **shall not attend oral argument** if they:

Are experiencing any symptoms of COVID-19 (fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea).

Have tested positive for COVID-19 within the past 5 days or are currently awaiting the results of a test, have been directed to isolate by a medical professional, or have had close contact with a person who has been diagnosed with COVID-19 within the past 5 days.

Arguing counsel shall notify the Court Crier, Brian Minner ((717) 412-5630 or [brian.minner@pacourts](mailto:brian.minner@pacourts)), if they display any symptoms of COVID-19, or test positive for COVID-19, within 5 days after oral argument.
