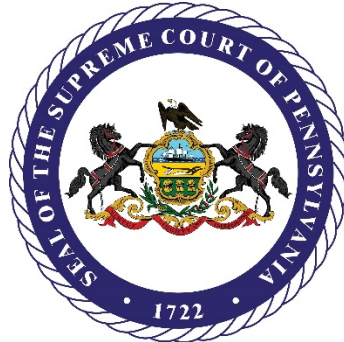


## Notice Regarding the Supreme Court of Pennsylvania's October 2022 Oral Argument Session
