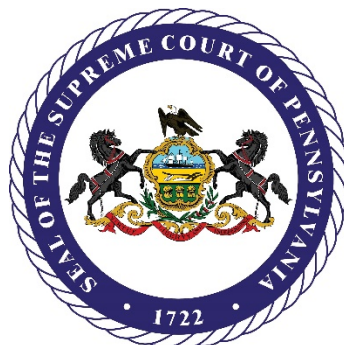


## Notice Regarding the Supreme Court of Pennsylvania's September 2021 Oral Argument Session

Masks will be required for everyone attending the Supreme Court's September oral argument session. Counsel may remove their masks while presenting oral argument.

Persons shall not attend oral argument if they:

Are experiencing any symptoms of COVID-19 (fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea).

Have tested positive for COVID-19 within the past 14 days or are currently awaiting the results of a test, have been directed to isolate by a medical professional, or have had close contact with a person who has been diagnosed with COVID-19 within the past 14 days.

Arguing counsel in either of the above categories shall file an application to submit the matter on the briefs or request a continuance to a future argument session.

Attendees may remain outside the courtroom until the case that they are arguing, or which they are interested in observing, is called. A break will be taken after each argument to allow attendees to enter the courtroom and to allow staff to sanitize common touch points.

Arguing counsel shall notify the Court Crier, Brian Minner (717-412-5630 or [brian.minner@pacourts](mailto:brian.minner@pacourts)), if they display any symptoms of COVID-19, or test positive for COVID-19, within 7 days after oral argument.
