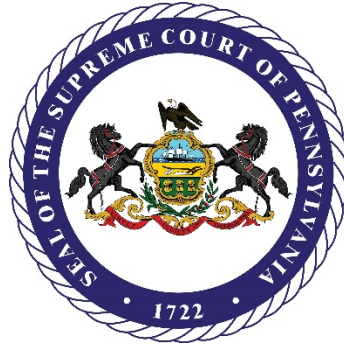


Notice Regarding the Supreme Court of Pennsylvania's September 2022 Oral Argument Session
